Update and Conversation with the Dean

Wrap-up All-College Meeting

Thomas wants to move forward with the Institute for Working Forest Landscapes proposal to get it ready to present at the November 15 FRL AC meeting. Thomas received several edits from the faculty. He will revise the proposal and send another draft. FEC discussed the acceptance of the plan. Everyone gave feedback on the Fall All-College meeting format and the context for the discussions and felt that this was a good, thought stimulating, meeting with a good turn-out. FEC discussed how to continue engaging all sectors of our college community. It was suggested to have more frequent smaller group meetings in addition to the twice a year All-College meetings and have again a discussion around College mission.

Next Step: Develop College mission statements and values. Schedule small groups 2hours follow-up meetings in winter term to discuss top issues.

• Update on the FES Department Head Search

The deadline for the FES Department Head candidate application submission is November 15. The Search Committee will identify the top 4 candidates shortly after that. The Dean plans to attend upcoming department meetings to answer any questions about the process. Laurie

Schimleck, Chair of the Search Committee gave an update.

• College Budget Update

Thomas Maness discussed the upcoming changes relative to the College budgeting. The College will be moving forward to a performance based budgeting model.

College Forest Director Position

Thomas gave an update on the new College Forest Director position that he and Jim Johnson have developed and reported on the interests he received for the position so far. This new position is a blend of an extension specialist and College Forests director who will have faculty oversight. Thomas reported on the external review that Mark Miller and Matt Fehrenbacher of Trout Mountain Forestry conducted on the McDonald Dunn Forest. The goals of this external review are to inform the College of the history, current status and opportunities associated with McDonald Dunn Forest and provide a common starting point for an eventual update of the McDonald Dunn Forest Plan.

The report will be presented at the November 8 FEC meeting. Thomas discussed the College Forests budget and his expectations. Further discussion will be needed on how to manage the College Forests for demonstration, research, and education.

ABET Accreditation

Marv Pyles provided an update on the accreditation process and time line. The ABET accreditation was originated in 1935. The last visit was in the fall 2008. The next visit is scheduled in the Fall of 2014. *Information Only.*
