Updates and Conversation with the Dean - Thomas Maness

Provost's Council (PC) Meeting Update

Dean Maness reported on the last Provost's Council he attended and brought back some items for discussion with the FEC on the College enrollment management plan for the future to meet OSU strategic plan. The Provost discussed the Colleges' progress on diversity/visible minorities hires. There is an ongoing discussion about next year's round of Provost's Faculty Hires being targeted to increase the diversity goal. FEC discussed new initiatives to achieve the College's priority #5: Diversified, Pluralistic College Community.

The committee is currently working on developing a list of recommendations for actions and strategies on diversity and pluralism of the College. The FEC discussed all the opportunities for diversifying the College population. *Follow-up discussion required.*

• 2012 Ecotrust Indigenous Leadership Award Dinner and Ceremony The College of Forestry hosted a table of guests at the Ecotrust Indigenous Leadership Award Dinner held on November 13. Five exceptional leaders from the tribal communities from Northern California to British Columbia were honored. Dean Maness discussed his interest in building relationship with the regional tribal groups, having a first nation house of learning for traditional learning out at the College Forests, and developing an aboriginal studies program.

Follow-up discussion required on CoF aboriginal Studies at future FEC meeting.

CoF Priorities Planning Process Update – Geoff Huntington/Thomas

 Geoff Huntington gave an update on the recruitment and interview process for the three associate dean positions. Applications submission will close on November 29. The Graduate Students Council will meet with the candidates for the AD for Graduate and International Programs for an informal conversation. Dean Maness encouraged anyone interested to apply for these positions.

Action Required: Develop interview questionnaire.

Geoff distributed copies of the summaries of the survey results on the CoF priorities for FEC's review. Dean Maness extended the opportunity for the College to engage and offer thoughts on any or all the priorities areas through the Thanksgiving week-end. Draft strategies should be in place by early December and will be sent back out for review and input. The teams should be in place in January.

Advisory Boards for the College

FEC discussed the role and structure of the College's advisory committee and raised the issue of balancing the FRL Advisory Committee's and Board of Visitors' engagements.

Follow-up required – Schedule 1 hour discussion on this topic in upcoming FEC.

Matching Funds for University Proposals – Steve Tesch/Thomas Maness FEC discussed a policy statement to clarify the expectations for the College's contribution of matching fund requests to be in function of the basis of use/access. The principals discussed were:

- 1) Have the access clearly described in the proposal,
- 2) Work with the Research Office from the start of the proposal to ensure that these criteria are met before these proposals gets to the FEC,
- 3) Have the policy communicated to the staff and research faculty and track the use,
- 4) Have the PIs invest some of their fund to be part of the match,
- 5) Expect that rules are made campus wide.
- 6) Recognize the ongoing cost of staffing of those who are managing the service.

Action Required – When formed the College of Forestry Research office will craft a policy.

Others Items

Dean's Awards Update – Thomas Maness

Dean Maness will continue the tradition of the Dean's awards and wanted FEC's input on changing the composition of the Dean's Awards committee and selection/decision making process. FEC suggested that the three members at large help operationalize the Dean's awards for this year.
